Measures for Providing the Special Fund for Standardization Strategy in Yuexiu District

Chapter I General Provisions

- Article 1. To promote the implementation of standardization strategy in Yuexiu District and accelerate the development of regional economy, these Measures are formulated in accordance with the Standardization Law of the People's Republic of China, the Detailed Rules for the Administration of Special Funds for Implementing Standardization Strategy in Guangdong Province, the Measures for the Administration of Special Funds for Standardization Strategy in Guangzhou, and other relevant regulations, and in combination with the actual standardization work in Yuexiu District.
- **Article 2.** These Measures shall be used to standardize the use of the special fund for the implementation of standardization strategy in Yuexiu District (hereinafter referred to as the "Special Fund").
- **Article 3.** Legal entities and other organizations that actively participate in the implementation of Yuexiu District's standardization strategy may apply for the Special Fund according to these Measures if they fall into the scope of funding listed herein.

Chapter II. Sources, Management and Use of the Fund

- **Article 4.** The Special Fund shall be arranged by Yuexiu District Finance Bureau and included in the departmental budget of Administration for Market Supervision of Yuexiu District.
- **Article 5.** Administration for Market Supervision of Yuexiu District shall use the Special Fund for the designed purpose, that is to fund projects concerning the implementation of standardization strategy.
- **Article 6.** Administration for Market Supervision of Yuexiu District is responsible for the implementation of these Measures.

Chapter III Funding Conditions, Scope, Projects and Quota

- **Article 7.** Standardization projects applying for the Special Fund shall meet one of the following conditions:
- (1) Comply with the industrial development direction of Yuexiu District, conducive to promoting the improvement of independent innovation capability and the standardization and industrialization of related scientific and technological achievements in Yuexiu District.

- (2) Have independent intellectual property rights, beneficial to boosting the combination of intellectual property rights and technical standards in Yuexiu District and enhancing the competitiveness of products in international and domestic markets.
- (3) Be conducive to promoting the adjustment and optimization of industrial structure of Yuexiu District and the comprehensive, coordinated and sustainable economic and social development of Yuexiu District.
- (4) Be conducive to protecting personal health and safety, promoting energy conservation and consumption reduction, improving the efficiency of resource recycling, strengthening environmental protection and enhancing the level of safe production, thus pushing ahead the construction of a harmonious society.

Article 8. The scope, projects and quotas of the Special Fund:

- (1) For organizations serving as the secretariats of international, national or provincial standardization technical committees or sub-committees, a one-time subsidy of RMB60,000 yuan, RMB40,000 yuan and RMB20,000 yuan will be granted as per the corresponding categories.
- (2) For organizations leading the formulation and revision of international standards, national standards, industry standards or local standards, RMB80,000 yuan, RMB50,000 yuan, RMB40,000 yuan and RMB30,000 yuan will be granted as per the corresponding categories.
- (3) For organizations building national standardization demonstration (pilot) projects will receive a one-time subsidy of RMB80,000 yuan after passing the acceptance of the competent standardization authorities; organizations building provincial standardization demonstration (pilot) projects will receive a one-time subsidy of RMB50,000 yuan after passing the acceptance of the competent standardization authorities; and organizations building municipal standardization demonstration (pilot) projects will receive a one-time subsidy of RMB30,000 yuan after passing the acceptance of the competent standardization authorities.
- (4) Organizations adopting international standards or advanced foreign standards and obtaining the "Adopting International Standard Product Certificate" will receive a subsidy of RMB2,000 yuan per item.

The accumulative amount of the subsidies received by an organization from the Special Fund shall not exceed RMB80,000 yuan every year. The accumulative amount of subsidies in the current year shall not exceed the budget of the fiscal year of the district. Otherwise, the final subsidies of the subsidized organization shall be the result of dividing the total financial budget by the percentage of the total subsidy amount in the current year, and then multiplying by the subsidy amount that should be given to such organization.

- **Article 9.** Administration for Market Supervision of Yuexiu District shall identify the projects applied for the Special Fund according to the following bases:
- (1) The identification basis for organizations serving as the secretariats of international, national and provincial standardization technical committees and sub-committees: The

documents approved by the International Organization for Standardization, the Standardization Administration of China and the provincial standardization administration department.

- (2) The identification basis for organizations leading the formulation and revision of international standards, national standards, industry standards or local standards: The official standard texts issued by the International Organization for Standardization, the Standardization Administration of China or relevant standard administration agencies. The organizations leading the formulation and revision of standards refer to the sole drafting organization, or the top three organizations in the preface of a standard document.
- (3) The identification basis for organizations building national, provincial or municipal standardization demonstration (pilot) projects: The documents for project approval and project acceptance from the Standardization Administration of China or the provincial or municipal standardization administration departments.
- (4) The identification basis for organizations adopting international standards or advanced foreign standards and obtaining the "Adopting International Standard Product Certificate": "Adopting International Standard Product Certificate".

Chapter IV Application Submission, Acceptance, and Examination and Approval

Article 10. Every year, Administration for Market Supervision of Yuexiu District will issue a notice to start the application submission. On the principle of voluntariness, the applicant organization shall submit a written application for funding within 2 years after the completion or approval of a project, and the delayed submission shall be deemed as giving up the application. In particular, the application time limit for standard formulation and revision projects shall be counted from the date when the standard is issued.

Article 11. The Administration for Market Supervision of Yuexiu District shall accept the application materials of each organization, and organize the examination according to the provisions of these Measures. After being studied and determined by the Party Group Meeting of the Bureau, the funding results shall be informed to the subsidized organizations, and the Bureau shall pay subsidies to the applicant organizations through the authorized payment channel.

Article 12. An applicant organization shall submit the following application materials (in duplicate) to the accepting organ:

- (1) The basic information
- a. Application Form for the Special Fund for Standardization Strategy in Yuexiu District
- b. Business License or Legal Person Registration Certificate (Organizations that do not apply for "Three-in-One" business license shall additionally provide the Organization Code Certificate. The original of the foregoing certificate will be checked on site without the need to provide a copy).

- (2) Other materials to be submitted according to the applied project (copies stamped with the official seal of the applicant organization shall be submitted, and the original shall also be presented for checking)
- a. Project application by organizations serving as the secretariats of international, national and provincial standardization technical committees: The documents approving the establishment of such standardization technical committees;
- b. Project application for the formulation and revision of international standards, national standards, industry standards or local standards: The official documents of such standard released;
- c. Application for standardization demonstration (pilot) projects: Valid documents for demonstration (pilot) project approval, acceptance evaluation or project objective evaluation;
- d. Application for projects adopting international standards or advanced foreign standards: "Adopting International Standard Product Certificate".

Article 13. Under any of the following circumstances, the subsidy application will not be accepted:

- (1) The applied project does not comply with Article 7 hereof;
- (2) The applied project does not comply with Article 8 hereof;
- (3) The applied project does not comply with Article 9 hereof;
- (4) The application materials provided are incomplete.

Article 14. There can only be one applicant organization for the same project. If two or more organizations meet the application conditions for the same project at the same time, they shall negotiate on this matter.

Chapter V Supervision and Administration

Article 15. The Special Fund shall be used for its designed purpose, and the scope of expenditure shall not be expanded and the payment standard shall be raised without authorization. It is strictly forbidden to intercept, misuse, misappropriate or defraud the Special Fund. The illegal use of the Special Fund shall be dealt with severely in accordance with the *Regulations on Punishment of Financial Violations* and other relevant provisions.

Article 16. Organizations granted the Special Fund shall consciously accept the inspection and supervision of finance, supervision, auditing and other relevant departments.

Article 17. Administration for Market Supervision of Yuexiu District and Yuexiu finance, auditing, supervision and other relevant departments shall, in accordance with their respective duties, supervise the use and administration of the Special Fund according to law.

Chapter VI Supplementary Provisions

Article 18. The phrase "implementing / implementation of standardization strategy" as mentioned in these Measures refers to engaging in the research and development of technical standards, the construction and management of professional standardization technical committees at all levels, undertaking the standardization pilot demonstration construction, and adopting international standards.

The term "international standards" herein refers to the standards formulated by the International Organization for Standardization (ISO), the International Electrotechnical Commission (IEC) and the International Telecommunication Union (ITU), as well as the standards formulated by other international organizations confirmed and published by the national standardization organizations.

Article 19. Administration for Market Supervision of Yuexiu District is responsible for the interpretation of these Measures.

Article 20. These Measures shall be implemented as of the date of promulgation and shall be valid for five years.
